\$ 2,000.00 Promoter sanction fee.

\$ 1,200.00 Champion sanction fee. Note: \$ 1,000.00 each if Title is vacant.

\$ 1,000.00 Challenger sanction fee. Note: \$ 1,000.00 each if Title is vacant.

NOTE: If combined purses is over \$ 100,000.00, the sanction fee for each boxer is 3% of their purse. The Minimum for the Champion is \$ 1,200.00 and \$ 1,000.00 for the challenger. Minimum of \$ 1,000.00 each if the Title is vacant.
